Policy Aim

SHORT TERM

MEDIUM/LONG TERM

- Review all waste contracts to see if they can be executed in a more environmentally friendly and economic way.
- Monitor our consumption and cost of utility services water, gas and electric.
- Promote activities to save costs on utilities.
- Incorporate environmental criteria into our purchasing agreements.
- Where possible encourage and implement positive environmental improvements designed to reduce the net carbon emissions of Nottingham Security Ltd.
- Commit to a long-term project of evaluating the level of environmental commitment demonstrated by suppliers and contractors to Nottingham Security Ltd, and encouraging the adoption of an Environmental Management System [EMS]
